

## Terms and Conditions

- Reservations can be made by contacting Executive Adventures Africa, hereinafter referred to as the "Company".
- Price subject to stipulated itinerary provided by Company.
- Executive Adventures Africa reserves the right to amend the quoted rates at its discretion at any time before Client has agreed to the said rate.
- To confirm a booking, a 30% non-refundable deposit is to be paid. The deposit is calculated at 30% of total reservation value. There shall be no binding contract until the deposit has been received by the Company.
- In addition to deposit, we will require the full amount for the African portion of your international airfare booked on your behalf (If Applicable)
- Balance of payment should be paid 90 days before commencement of safari.
- Baggage allowance of 23 Kilograms or 50 pounds per person allowed on economy airfare.
- Baggage allowance of 15kg or 50 pounds per person on domestic schedule charters

### Cancellation Policy

- Any cancellation of a reservation must be in writing and shall only be effective upon its acknowledged receipt by the Company.
- If you are a no show, the Company shall be entitled to treat your reservation as cancelled without having given the Company any notice.
- In the event of a confirmed reservation being cancelled, the following cancellation fees will apply.
  - 30% of the total reservation value if cancelled up to 91 days before arrival.
  - 100% if cancelled 90 days or less prior to arrival
  - 100% of your African portion of the international airfare booked on your behalf (if applicable)

### Risks

- The Company draws your attention to the fact that there are certain inherent risks involved in participating in a safari, and that you accept them at your own risk.
- With your acknowledgment of these Terms and Conditions, you agree to participate whether in populated or unpopulated areas, either by foot, boat, plane or other conveyance and certain risks maybe present any time before, during or after your safari. These maybe causes unknown, forces of nature, negligence of others where risk of illness, injury, death, property loss or damage is possible.
- It is your sole responsibility to take all appropriate medical advice prior to departure as to whether you are fit enough to undertake the trip booked. The Company shall not be liable for illness, injury or death sustained on a program sold by the Company which is not due to the gross negligence of the Company, its officers, employees, authorised representatives or agents whomsoever.

### **Force Majeure**

- “Force Majeure” means, in relation to the Company, any circumstances beyond the reasonable control of the Company (including, but without limitation, acts of God, explosion, flood, tempest, fire or accident, war or threat of war, sabotage, insurrection, civil disturbance or requisition, sickness, quarantine, government intervention, weather conditions or other untoward occurrences). It shall also include whereby government concession areas are no longer made available to said Company.
- The Company shall not be deemed to be in breach of these terms and conditions or otherwise be liable to you, by reason of delay in performance or by non-performance of any of its obligation hereunder, to the extent that any such delay or non-performance is due to any Force Majeure.
- If the Company is affected by Force Majeure it shall be entitled to, and may in its sole and absolute discretion, vary or cancel any itinerary or arrangement in relation to the trip. Payment of any refund by the Company to you as a result of the non-performance of any of the Company’s obligations hereunder shall remain in its sole and absolute discretion although the Company shall use its reasonable endeavours to reimburse you where possible. However, the Company shall be entitled to deduct from any refund recoverable the reasonable actual and potential costs to the Company of the Force Majeure.
- Regarding civil unrest, once the Company has investigated the prevailing situation as it deems fit, it shall remain in the Company’s sole discretion whether to proceed with the trip. You may in such circumstance cancel the trip. However, if after having made all the reasonable and proper enquiries, the Company is of the opinion that the trip may proceed, no refund will be payable to you and the provisions of Paragraph 2 shall apply.

### **Insurance**

The Company strongly recommends that you obtain the following types of insurance which are commercially available:

- Accidental death and disability
- Major medical
- Trip insurance
- Emergency medical evacuation
- Loss of personal effects

### **Includes**

- All accommodation, food, water and soft drinks on stipulated dates.
- All transfers to and from International Airports as per your itinerary.
- All game drive vehicles with drivers.
- All National Park fees.
- All internal charters in Tanzania.
- All Gratuities
- House wines, local beers and spirits subject to the individual lodges discretion

### **Excludes**

- All international flights from USA to Africa
- All premium brands spirits and premium brands of wine and champagne.
- All spa treatments
- All purchases at gift shops
- All personal purchases
- Personal Visas for entering Countries
- Overweight charges for luggage on international flights
- Personal expenses
